

RT-50/HACCP, RT-60/HACCP Wall mounting electric insecticides with glue trap

Description

Electric insecticides are used to exterminate various insects. They use special fluorescent tubes (Black Light) to attract the insects from a distance. They can be used in any areas where there are many insects. These models use lamps with special plastic shell to protect the area from broken glass parts in case of a broken lamp. A special glue trap within the insecticide is used to trap the insects. If they are placed outdoor then a special external metallic grid is available to protect birds that might happen to come near the trap. These traps protect us from all kinds of insects (mosquitoes, gnats, flies, e.t.c) without using any chemicals. The insecticides are mounted high above the floor level and in a clearly visible place in order to attract the insects more easily. One glue trap is included in the packaging of the electric insecticide.

RT-50/HACCP. This model uses a special glue trap for insects and incorporates one 18W special fluorescent tube (blacklight) placed in the front of the glue trap. The device is powered by a voltage of 220-240V AC.

RT-60/HACCP. This model uses a special glue trap for insects and incorporates one 36W special fluorescent tube (blacklight) placed in the front of the glue trap. The device is powered by a voltage of 220-240V AC.

Spare Parts- Replacements

- **A1066.** A package that contains 6 replacement glue traps.
- **A1068.** A package that contains 12 replacement glue traps.
- **A1056.** External metallic protection grid. (1 for **RT-50/HACCP** and 2 for **RT-60/HACCP**)

Changing the lamps or the Starter

If the lamp or the Starter must be changed, this procedure can be done by the user, by following the procedure below:

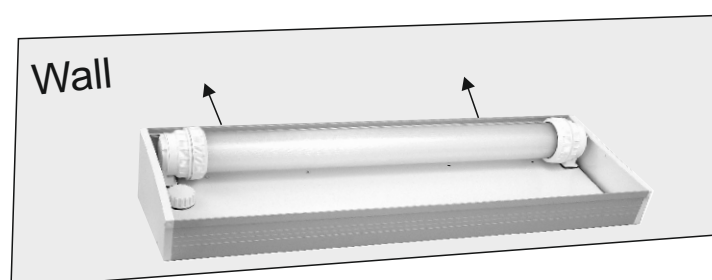
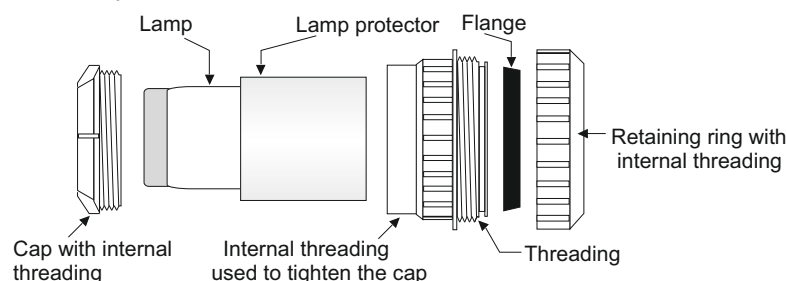
1. Remove the power plug from the wall outlet.
2. Replace the Starter or the lamp which is not operating with one of the same type.
3. Insert the power plug into the wall outlet.

The lamp type used are: **SYLVANIA** type **T12 F18W/BL350S** for **RT-50/HACCP** and **T8 F36W/ BL368FEP** for **RT-60/HACCP**.

Maintenance

The glue must be replaced once a month for maximum efficiency of the insect trap.

In periods where high quantities of insects are observed or if the insect trap has been installed in areas with high levels of dust then the glue trap must be checked more frequently. If the surface of the glue is covered with dust or insects then it must be replaced.
